



## Directions to Atlantic

### From Route 17 North or South:

Travel on **Route 17 toward Paramus** where it intersects with Route 4.

**Exit 17 onto Route 4 West** and continue for about 1½ miles. Road will split 3 ways; take the center choice which is **Route 208 North** (Oakland).

Follow **Route 208 North** through Fair Lawn and you will see the **NABISCO** factory. Just past Nabisco is the **exit for Maple Ave.** Follow the signs for **Maple Ave. - Paterson / U-TURN** and you will **loop over 208**. Bear to the right following the signs for **ROUTE 208 South** and you will end up back on the South bound side of Route 208.

Continue straight on **208 South** and you will pass the **Maxell** a sign that says **FAIR LAWN AVE ¾ Miles**. Next you will see Columbia Bank on your left as you continue on 208 South. The next sign you see will say **FAIR LAWN AVE KEEP RIGHT. Our Entrance is about 50 feet past this sign. (Move to the shoulder of the road)**

We are the first building on the right. **Our address 16-17 ROUTE 208 South**. The building is a **big YELLOW HOUSE**, there are two driveways. Enter the second driveway by the **Blue Atlantic Sign**. Parking is in the back and our entrance is on the side.

### FROM ROUTE 287 and ROUTE 208

From Route 287 North take Exit #59 for Route 208 South Franklin Lakes.

Follow 208 South for about 7 Miles. When you enter Fair Lawn you will see NABISCO on your left.

Continue straight on **208 South** and you will pass the **Maxell** a sign that says **FAIR LAWN AVE ¾ Miles**. Next you will see Columbia Bank on your left as you continue on 208 South. The next sign you see will say **FAIR LAWN AVE KEEP RIGHT. Our Entrance is about 50 feet past this sign. (Move to the shoulder of the road)**

We are the first building on the right. **Our address 16-17 ROUTE 208 South**. The building is a **big YELLOW HOUSE**, there are two driveways. Enter the second driveway by the **Blue Sign**. Parking is in the back and our entrance is on the side.



## **From Route 80 East or from the Garden State Parkway North or NJ Turnpike**

**From the NJ Turnpike North:** take exit 11 for the Garden State Parkway North, you will be getting on the Parkway at approximately exit 129. Follow the Parkway North to Exit 156.

**From Route 80 East:** take Exit 60 and Follow the Signs for Route 20 North (Hawthorne).

**From the Parkway North:** Exit 156 is for Route 20 North (Hawthorne)

Once you are on Route 20 follow the signs for 20 North (Hawthorne). You will pass **Hanna Krause Chocolates**, continue on Rt. 20 and about 3 Miles on your right will be a Burger King.

Continue on Route 20 North past the Fair Lawn Ave. Bridge and the road will end with a sign for MAPLE AVE. (At that point you will **see a "GAS" GAS STATION** in front of you) **Make a right** turn just before the Gas Station and you will **cross over** the Passaic River. You are now on Maple Ave. Take Maple Ave. approximately 1 mile and you will see signs for Route 208 South. The entrance for 208 South is just past the **TOYOTA** Dealership.

Continue straight on **208 South** and you will pass the **Maxell** a sign that says FAIR LAWN AVE  $\frac{3}{4}$  Miles. Next you will see Columbia Bank on your left as you continue on 208 South. The next sign you see will say **FAIR LAWN AVE KEEP RIGHT. Our Entrance is about 50 feet past this sign. (Move to the shoulder of the road)**

We are the first building on the right. **Our address 16-17 ROUTE 208 South.** The building is a **big YELLOW HOUSE**, there are two driveways. Enter the second driveway by the **Blue Sign**. Parking is in the back and our entrance is on the side.
